“All disputes and/or disagreements of any kind or description which may at any time, from the date of signing the present agreement, either during the period of enforcement or at or after the expiration or termination of same, arise between the contracting parties hereof and which concern and/or are related to the interpretation, the validity or any of them or by virtue of the present agreement, or in any other way or in any other matter which is connected or arises in whichever way in relation to the subject matter of the present agreement shall be referred to arbitration before one arbitrator to be appointed by the Cyprus Arbitration and Mediation Centre within 15 days from the date in which a relevant notification shall be sent by one party to the other for the appointment of an arbitrator with. copy to the General Secretary of Cyprus Arbitration and Mediation Centre. Such arbitration shall be carried out by the rules of arbitration as applied by the Cyprus Arbitration and Mediation Centre”

If the proposed parties have no agreement to submit their dispute or disagreement to arbitration then such agreement shall first be entered into and then file the application. Such agreement must contain a term in the following term or as near thereto as possible

*“As the parties hereto are bound by a contractual agreement dated the day of.....
20....., (hereinafter called the "Basic Agreement" and differences have arisen between them and which
concern and/or are related to the interpretation, the validity or any of them of the Basic Agreement or by
virtue of the Basic Agreement, or in any other way or in any other matter which is connected or arises in
whichever way in relation to the subject matter of the Basic Agreement shall be referred to arbitration
before one arbitrator to be appointed by the Cyprus Arbitration and Mediation Centre within 15 days
from the date in which a relevant notification shall be sent by parties hereof to the General Secretary of
the Cyprus Arbitration and Mediation Centre requesting such appointment of an arbitrator.”*
