

Mrs Stefania Floraki was born in Limassol on the 12th of March 1980 and she is the second child of her family. Until the year 1994 she has been living in several places of Greece and Cyprus, and since 1994 she is living in Paphos, except from the period of her studies abroad. She is married to Mr. Christodoulos Christodoulou, and together they have two lovely children, Evanglelos and Georgia Christodoulou.

She graduated with honors from the A' Lysium of Paphos, Lysium of Ethnarchis Makarios the III, and after attending the general exams of Cyprus, she obtained a position at the Law Department of the School of Law, Economics and Politics of the Aristotelion Univercity of Thessaloniki, from where she graduated with a Second Class Degree.

Mrs Floraki has been registered at the Cyprus Bar Association and is a member of the Paphos Bar Association since 2005, after succeeding to the Bar Examinations.

Until March of 2009, she was working for the Law Office of George A.
